Material Description

MasterJoint™ WP 680 is a flexible waterproofing membrane used for waterproofing vertical and horizontal direction under tiles in wet rooms and pools.

Processing Method

(A) Preparation of Substrate

Application surface must be sound, dry, dustless, clean, and also in balance. Surface must be free of all kind of bond breaking residues such as oil, grease, rust, and paraffin. Irregularities on the substrate must be repaired with MasterJoint™ 591/ 596 or MasterCrete[™] S 88C.

(B) Processing

Cut **MasterJoint**™ **WP 680** cut required size. Lay MasterJoint™ WP 680 onto a fresh layer of FMörtel® S1 tile adhesive. Apply pressure over the membrane

with a plastic plastering trowel avoiding air bubbles under the membrane. It is recommended to smooth the membrane outwards from the middle of the membrane to the edges.

Suitable width of overlaps must be a minimum of 50

Point to Consider

- MasterJoint™ WP 680 must be placed on the wet coating. If the coating is fully cured, apply another coat and place in the wet coating as described.
- Do not use sharp tools for application
- MasterJoint™ WP 680 must be covered completely with waterproofing coating.
- Please check the application instructions of the waterproofing coating used for bedding the joint tape.

Storage

Must be stored in closed package in a cool and dry warehouse protected from freezing and direct sunlight.

Shelf Life

24 months from production date.
